Case Summary:

Fom 1984 to 1991 Andrew and Ruth Weibel operated an unpermitted landfill on Highland Shores Drive. During this time they violated the Solid Waste Disposal Act and the Texas Clean Air Act on numerous occasions. They also evaded the law by refusing to allow county and state investigators access to their property and failing to be present at hearings.

In August of 1987, Harris County filed a law suit against Andrew and Ruth Weibel for environmental and public safety violations, including unauthorized outdoor burning, failure to properly cover waste, and noncompliance with officials. The Weibels failed to be present for their trial. The court judgment called for the permanent injunction of the Weibels from their property. This included a civil penalty of over \$500,000 for the remediation of the environmental problems they caused.

The Weibels did not respond to this notice and in 1991 they were arrested and charged with contempt. In addition to the penalties from the injunction, they spent three months in jail and were charged a \$250,000 fine. Harris County took over the management of the Weibel site and turned it into a protected wetlands area.

Scope and Contents Note:

Legal documents, correspondence, notes, printed materials, maps, and photographs (1984-1993) document the investigation of the Weibel landfill, the ensuing litigation, and the restoration of the site to a wetlands area. Legal documents from 1984-1991 include several drafts of the original petition for the lawsuits against the Weibels, witness

Correspondence contains notices sent from the Harris County Attorney's Office to the Weibels, as well as interdepartmental communication. Printed materials include newspaper articles about the Weibel landfill, proposals for the clean-up effort, and materials from the Allwaste conference in 1992. There are several maps showing the layout of the Weibel property. 32 photographs and 16 35mm slides (1985-1993) document the Weibels' violations.

Archivist's Note:

This collection has been minimally processed, maintaining original order and titles of the folders and only separating photographs. Be sure to read the entire inventory.

Also see VHS tapes from Terrence O'Rourke Papers (MC48), numbers 257, 358, 597, and 651, documenting Andrew and Ruth Weibel's violations and noncompliance.
