**Creator Sketch:**

Robert Allen Eckels was born on March 14, 1957, in Houston to Robert Young and Carolyn Bickley Eckels. He attended Houston Christian High School and graduated from the University of Houston with a Bachelor of Science in Technology. While attending college he worked as a Deputy Constable on the west side of Houston.

In 1982 Eckels was elected to the Texas House of Representatives, District 133. During his service in the Legislature, he served on several legislative committees including Government Organization (Vice Chair, 1989), Environmental Affairs (1989), County Affairs (Chair, 1991) State Affairs (Chair, 1991; 1993), and House Calendars (1993). In 1993 Eckels was the first Republican ever elected to chair the Democratic controlled Harris County Delegation. He was named one of the “Ten Best” legislators by *Texas Monthly Magazine* and “Legislator of the Year” by the National Republican Legislator Association. In 1993 Eckels received his Doctor of Jurisprudence from the South Texas College of Law, and is a member of the American, Texas, Houston, Colorado, Denver, New York, and Washington D.C. Bar Associations.

After serving six terms in the Legislature, Eckels decided to run for Harris County Judge, he defeated Democratic candidate Vince Ryan. In 1995, his first year in office, he initiated department performance reviews which found millions of dollars in savings. He introduced competition from private sector, reducing the cost of government services, and cut the number of departments in half, reducing costly service duplications, improving communication and accountability. Eckels also established the Juvenile Justice Alternative Education Program (JJAEP) which removes troubled youths from public schools and places them in a rigorous and structured learning environment. He funded after school programs in cooperation with Harris County Department of Education and Texas Workforce Commission, and opened the Children’s Assessment Center, a treatment center for sexually abused children.

Eckels improved open government by placing the Harris County Commissioners Court Agenda on the internet and televising Commissioners Court meetings. He reorganized Harris County emergency management by relocating Harris County, City of Houston, METRO, and TxDOT departments under one operation at TranStar. In 1996 he fought a tax increase, because he believed it to be unnecessary for the county's \$1.2 billion budget.

Eckels received international recognition when Harris County responded to Hurricane Katrina that led to massive destruction and loss of life in New Orleans and the Gulf Coast. The Harris County Astrodome and Reliant Center became the largest shelter operation in US history as over 250,000 residents from storm damaged areas fled to the Houston area.

In March of 2007, just 4 months after his reelection, Eckels resigned to become a partner in the international law firm of Fulbright and Jaworski. He left that law firm in 2009 and became founding chairmen of the Texas High Speed Rail and Transportation Corporation. In 2010 he became the president of Lone Star High Speed Rail, LLC. Eckels currently works for Gray Reed & McGraw, P.C.

A longtime Houstonian, Eckels is married to Jet Winkley and they have one daughter, Kirby Rae.
