Scope and Contents Note:

Records document Harris County Attorney opinions from 1953 to 1992, during the terms of County Attorneys: Burke Holman (1953-1956), Joe Resweber (1957-1980), and Mike Driscoll (1981-1995). In addition the collection includes Texas Attorney General financial opinions from 1925-1962 and Indexes listing Attorney General Open Records decisions from 1967-1988. Of particular interest is the November 27, 1963 opinion regarding the liability of Harris County under contract with architects for the Harris County Domed Stadium (Astrodome). Folders are arranged primarily by case number and subsequently chronologically.
